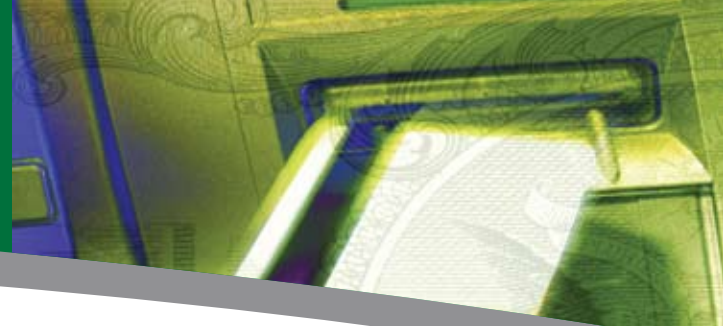

1. Open your ROCKLAND FEDERAL CREDIT UNION Checking Account.

Visit our web site at www.rfcu.com and complete and submit the New Account Application by selecting **Membership/How to Open an Account**. You may also visit any one of our branch locations, or call the Member Information Center at (781) 878-0232 or (800) 562-7328.

2. Complete the “Switch Kit” Forms

Direct Deposit Change Notice

This form may be used to redirect all direct deposits. Complete and submit this form to your employer to authorize direct deposit of your payroll into your new Rockland Federal Credit Union checking account.

You can attach a copy of a voided check from your Rockland Federal Credit Union starter kit for reference.

Automatic Payment Change Notice

Complete and submit this form to any company who will be withdrawing funds from your new Rockland Federal Credit Union checking account.

3. Close Your Old Checking Account

Once your Rockland Federal Credit Union checking account is open, you know your direct deposit is being credited to your Rockland Federal Credit Union checking account AND you know all your checks have cleared your OLD checking account, notify your old institution to close your account.
